It will be the prime responsibility of the incumbent CEO to ensure growth and sustainability of the organization by adopting global best practices. The incumbent should be professionally qualified and should have a proven record of setting high standards in leadership.

The candidate should possess professional qualification viz., MBA OR equivalent Post Graduate Management Degree/Diploma OR Post Graduate Degree/Diploma in Hotel Management.

2. **Age:**

The age of the candidate shall not be more than 62 years, for the candidates working/worked in PSU and 57 years for the candidates working in Private Sector as on the date of notification. The Contract shall be valid for a period of 03 years, extendable by 02 years based on performance or up to the age of 65 years whichever is earlier.

3. **Experience:**

Candidate should have 20 years of Managerial experience out of which at least 05 years of experience at senior managerial level (not more than two levels below CEO/Head of the Institute in Hospitality Sector, preferably in Aviation Sector).
